2. The documentation for the welding of railway vehicles must be sent for assessment to the extent pursuant to the applicable legislation.
3. Only basic and additional material predefined by the approved technical documentation and approved technological procedures will be used for welding. The material used must have an inspection certificate under STN EN 10204:2005.
4. Permanent supervision and recording of performed works will be carried out and prespecified documentation will be kept.
5. All activities within the scope of the issued authorization will be performed only by authorized workers with predefined qualifications.
6. Supplier activities, which are specified activities pursuant to Act no. 513/2009 Coll. on railways and on the amendment of certain laws, as amended, must be carried out by entities with an Authorization issued by the Transport Authority.

Notice:

Any change that affects the basic conditions of activity under this Authorization must be approved by the Transport Authority.

If the safety authority discovers serious deficiencies in the performance of the specified activities, or discovers non-compliance with the terms of this Authorization, it will initiate proceedings to limit the scope of the Authorization or to cancel it.
