Annex 1 to the Authorisation Reg. No. E-31/2023

This Authorisation applies to the implementation of:

Assembly, repairs, maintenance, reconstruction and testing of designated technical electrical equipment on railway tracks according to Article 17 par. 1 a) of the Railroads Act and according to Decree of the Ministry of Transport, Posts and Telecommunications of the Slovak Republic No. 205/2010 Coll. on designated technical equipment and designated activities and activities on designated technical equipment, as amended (hereinafter referred to as the "Decree No. 205/2010 Coll."):

- a) E2 Railway electrical networks and electrical distribution systems up to and including 1,000 V AC and 1,500 V DC,
- b) E6 Electrical equipment of railway track vehicles, including wagons and track mechanisms,
- c) E10 Railway electrical equipment test facilities.

Conditions of the authorisation, specifying the requirements for carrying out designated activities:

For the activities under this Authorisation, the following conditions must be met:

- The technical documentation, according to which the activity is carried out, must correspond to the Slovak Technical Standards, legal regulations, the actual design of the electrical equipment and the condition found during verification.
- 2. Activities provided in the framework of cooperation by other entities shall only be accepted from legal entities which are authorised to carry out the designated activities in question pursuant to Article 17 par. 2 of the Railroads Act.
- The designated activities must be performed by persons employed with professional competence for the performance of activities on designated technical equipment pursuant to Article 18 of the Railroads Act and Article 22 of Decree No 205/2010 Coll.
- 4. The performance of the designated activities shall be ensured according to the condition found during the examination of the legal entity's professional competence and conditions for performing the designated activities.
- 5. Notify the safety authority of changes in the facts which were decisive for the issue of the authorisation within 15 days from the date on which the changes occurred.

Notice:

If the safety authority finds any serious deficiencies in the performance of the designated activities which may affect the safety of operation of the designated technical electrical equipment or the safety of the operation of the railways or of transport on the railways, or finds non-compliance with the conditions of the authorisation, the safety authority shall initiate proceedings to limit the scope of the authorisation or to revoke it.

For the issue of authorisation under special regulations for the implementation of the designated activities in the field of designated technical equipment on railways, an administrative fee according to item 203 a) of the schedule of administrative fees of the Act of the National Council of the Slovak Republic No. 145/1995 Coll. on administrative fees as amended, in the amount of €104,- was paid on 31 May 2023 by bank transfer. The applicant has thus performed his obligation to pay the fee in full.
